RULES: The Regatta will be governed by the 2013-2016 Racing Rules of Sailing, the prescriptions of US Sailing, ISAF RRS, the Procedural Rules of the Interscholastic Sailing Association, this notice of race, the sailing instructions, MISSA By-laws and District rules.

DATE: Sunday, October 23, 2016

ELIGIBILITY: This regatta is the Pumpkin Regatta, Tier 3. Mixed teams are welcome. We have 16, 420s available. If we need more, we will ask you to bring boats. Membership in MISSA is required.

FORMAT: The regatta will consist of A and B divisions of 420s (no traps, spinnakers or mainsheet bridles). Round Robin format and one race constitutes a regatta.

Extra lunches will be available for coaches and spectators for a nominal fee. Sailors must have a refillable water bottle.

A damage deposit of \$250.00 per school must be submitted by Sunday morning, October 23. This is refundable if the boat and gear are returned undamaged.
