



## **NOTICE OF RACE** *April 18 & 19, 2015*

**OPEN TEAM RACING REGATTA  
SILVERDALE, WA**

*Backup for District Championship*



### **1. RULES**

1.1 The regatta will be governed by the Racing Rules of Sailing for 20013-2016, including Appendix D, the prescriptions of US SAILING, the ISSA Procedural Rules, this Notice of Race, and the Sailing Instructions. However,

- A. the US Sailing prescriptions to rules 60, 63.2, and 63.4 will not be in effect; and
- B. under rule 70.5(a), the right of appeal is denied

1.2 Rule 82, Indemnification and Hold Harmless Agreements, is deleted and will not apply

### **2. ELIGIBILITY**

2.1 Current ISSA and NWISA membership is required and will be verified at the time of final registration at the regatta site.

2.2 A responsible adult leader must accompany teams at all times

2.3 A varsity team ("gold fleet") shall consist of a minimum of 6 and a maximum of 9 sailors who are full time students in the 9th grade or higher, attending the same high school.

2.4 There are no numerical or age restrictions, or school restrictions on junior varsity ("silver fleet") competitors.

### **3. ENTRY AND COMMUNICATIONS**

3.1 Eligible schools shall email Steve Trunkey (strunkey.sail@comcast.net) their intent to participate and total number of sailors attending no later than 4/14/2015. Please Use the registration form online.

3.2 Teams unable to compete shall notify the Regatta Chair as soon as possible.

3.3 Entry fee includes

### 3.4 Damage

In the event that damage to a boat cannot be attributed to a particular team, the repair cost will be divided evenly between all the teams competing.

1000 First Warning: Racing will continue throughout the day.

Eat during boat rotation – no lunch break.

Racing will continue until late, weather permitting and daylight permitting.

1800 Dinner Served

### **Sunday, April 19, 2015**

0700 Continental breakfast. Depart Scout Hall by 8AM.

0830 Report Time

0930 First Warning: Racing will continue throughout the day.

Eat during boat rotation – no lunch break.

1500 No Warning for the first race of any round after this time, except for tie-breakers

Any changes to the schedule will be posted on the Official Notice Board.

## 6. RACING AREA

6.1 The racing area will sailed on Dyes Inlet at Waterfront Park in Silverdale.

6.2 Rotations will be from the leeward side of the main dock in the vicinity of the starting and finishing lines.

## 7. COURSES

7.1 Based on conditions, the Race Committee will determine the courses as prescribed in ISSA PR Appendix 6.

## 8. SCORING

8.1 The regatta will be scored in accordance with ISSA Procedural Rules.

8.2 If results from this regatta are used for determining National participation, scores for ineligible teams will be dropped.

## **9. LODGING**

- 9.1 Saturday housing is available at the Silverdale Scout Hall. Two coin operated showers are available at the park. Silverdale also has a YMCA with guest access, theaters, bowling alley, a mall, and numerous restaurants.
- 9.2 You must provide your own sleeping bag and pillow.
- 9.3 Each team is responsible for supervising their sailors at all times during the regatta and while at provided housing.

## **11. COACHING**

- 11.1 Team leaders, chaperones, coaches, parents, advisors and other support personnel shall not go afloat in the sailing area from the start of racing Saturday to the end of racing Sunday UNLESS an exception has been explicitly permitted by the regatta chair or PRO.
- 11.2 Competitors may receive coaching including instructions, assistance, equipment or sustenance only while on the designated rotation float or on shore.

## **12. OFFICIAL NOTICE FOR ALL PARTICIPANTS**

- 12.1 No contestant shall use, either on or off the water, alcoholic beverages (beer, wine, distilled spirits), or use any controlled substance (marijuana, cocaine, etc.), the possession of which is unlawful. An alleged breach of this rule and/or other disciplinary matters that occur may be the basis for a hearing under rule 69.1. The protest committee for such a hearing will be the Regatta Chairperson, a member of the NWISA Board of Directors and the chairperson of the protest committee.

Inconsideration of my/our use of sailing or rowing watercraft and participation in the program, I agree to RELEASE, HOLD HARMLESS AND INDEMNIFY the Kitsap Sailing & Rowing Foundation, the Port of Silverdale, and individual volunteers providing assistance during the program from any and all liability, claims and causes of action arising out of or in any way connected with my participation. Or the participation of any minor that I am signing on behalf of, in any activities offered by the Kitsap Sailing & Rowing Foundation, the Port of Silverdale, and individual volunteers providing assistance during the program.

I personally assume all risks in connection with these activities. If I am signing on behalf of a minor, I further agree to HOLD HARMLESS AND INDEMNIFY the Kitsap Sailing & Rowing Foundation, the Port of Silverdale, and individual volunteers providing assistance with sailing or rowing watercraft from all liability, claims and causes of action which the minor may have arising from the minor's participation in activities. The terms of this agreement shall serve as a release and indemnity agreement for my heirs, personal representative, and for all members of my family, including any minors.
