### SAILING INSTRUCTIONS

**1 RULES** This regatta will be governed by the Racing Rules of sailing 2017-2020, the Prescriptions of US SAILING, the ISSA Procedural Rules, the SEISA District Rules, the Notice of Race, and the Sailing Instructions.

**2 ENTRIES** Competitors may enter by delivering a completed entry form & waivers at [seisa.hssailing.org](http://seisa.hssailing.org) and paying the \$25.00 per sailor entry fee & \$50.00 deposit per boat to **Bay Access** before 0930 Jan 28, 2017 at the Seahorse Lounge at LYC.

**3 NOTICES TO COMPETITORS** Notices to competitors will be posted on the official notice board located in the Seahorse Lounge.

**4 SIGNALS MADE ASHORE** Signals made ashore will be displayed from the flagpole located at the Opti Launch Ramp. If a postponement is signaled ashore, the warning signal will be made not less than 30 min. after flag AP is lowered. This changes Race Signals AP.

**SCHEDULE** A competitors' meeting will be held at 1000 in or outside the Seahorse Lounge. The warning signal for the first race will be at 1045. Subsequent races throughout the day will be held as soon as possible after the end of the previous race.

**6 RACING AREA/COACHING** The race area will be on Clear Lake immediately outside of the Lakewood Yacht Club break walls. Rotations will occur off the large power boat slips immediately inside the break wall. Competitors may receive coaching, including instruction, assistance, equipment or sustenance, only while on shore.

**7 COURSES** The course[s] will be in accordance with ISSA Procedural Rules, with W-L courses preferred, approx. 15 – 20 minutes in length. Marks will be described at the competitor's meeting. In accordance with ISSA PR 7.7(c) after the starting signal, the race committee may change the position of any mark to maintain course configuration, provided that no boat is on that leg of the course. No signals are required (changes RRS 33).

**8 SHORTENING AND ABANDONING RACES** In accordance with ISSA PR 7.7(d) races will *not* be shortened. They will be abandoned. No signals are required. A race may be abandoned at any time at the discretion of the race committee, in consultation with the protest committee if possible.

**9 STARTING AND FINISHING LINES - STARTING SYSTEM** The starting and finishing lines will be between red/orange balls. *The Sound Signal Starting System in Appendix S of the racing rules will be used.* Races will start in accordance with ISSA PR 7.8(a). Individual recalls will be made in accordance with RRS Appendix S6. General recalls will be signaled by a series of short whistles. After a general recall, the round the ends provision of RRS 30.1 shall apply except Flag I need not be displayed in accordance with ISSA PR 7.8(b) (Changes RRS 30.1). rule 28.1.

**10 PROTESTS** Protests shall be filed in accordance with ISSA PR Part VI within 30 minutes after the race committee finish boat docks. Per Procedural Rule 8(b), competitors shall not communicate with a coach before reporting to the race committee immediately after finishing their intent to protest. Breakdown requests shall be filed in the same manner as protests.

**11 SCORING/ FORMAT** 10 or more races are scheduled. All scores will count. Three races in each division constitutes a regatta. A/B format will be used. Rotation sheets will be posted at the end of the competitor's meeting.

**12 SAFETY** Per Procedural Rule 2.2, competitors shall wear USCG approved wearable lifejackets.

**13 WAIVER OF LIABILITY** Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 4, Decision to Race. The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.

**14 RIGHTS TO USE NAME AND LIKENESS** By participating in this event, competitors automatically grant to the Organizing Authority and the event sponsors the right, in perpetuity, to make, use and show, at their discretion, any photography, audio and video recordings, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.
