The conclusion was that the best option for ISSA is to file for a "Group Exemption" from the IRS. This process would permit ISSA to have tax exempt status in all states and allow ISSA to list all sub-entities which would also be tax exempt. This would save the district LLC's from the annual expense of the state filing fees. Motion to approve the IRS filing fee of $\$ 3,000$ for the Group Exemption with a donation of $\$ 1,500$ that has been pledged by John O'Connor to help offset this expense.
