NOTICE OF RACE

1. RULES:

The regatta will be governed by the 2017-2020 ISAF RRS, and will be run in accordance with the current Interscholastic Sailing Association Procedural Rules (unless modified by this NOR), the Notice of Race, the Sailing Instructions, and the MISSA By Laws.

2. Format: The regatta will consist of A and B Divisions. Round Robin format, Fleet Race.

3. ELIGIBILITY:

A "Team" shall be made up of a minimum of 4 sailors and maximum of 8 sailors, between the grades of 7-12. This is a Tier 3 event. Mixed teams (comprised of students from different schools) shall be allowed. However, we would like to encourage teams of students from the same high school to form first, and then create mixed teams with the remaining sailors.

B. This event is limited to 32 teams.

C. Membership in MISSA is required.

4. BOATS: Club 420s, we will provide some 420's, if we need more, we will ask that you bring boats.

5. ENTRY:

The Entry fee is \$30 per sailor plus an Eventbrite service fee. This fee will be paid directly to the Leukemia & Lymphoma Society. This registration will be made through the Event Brite web site. Once registered, each participating school will be provided a "school fund raising" page, which may be used to generate more donation funds for each school. Additional details of this registration will be provided on another document. Registration will be limited to two full teams per school, to allow maximum number of schools participating. If there is space, the registration of additional teams will be permitted. Lunch will be provided for competitors and coaches.

Entry deadline for this event is Sunday April 28, No refunds after May 4th.

A damage deposit of \$200.00 is required. A check for \$200.00 payable to: **Brother Rice High School** must be mailed to: Kelly Bannasch, 2032 Derby Road, Birmingham, MI 48009, and received by May 4th.

8:00 AM – Arrive at Grosse Pointe Yacht Club and check in. 8:00 – 9:00 AM – Boat set up, preparation. 8:30 AM – skipper's meeting.

9:00 AM – Launch

9:30 AM – Start 1st race. We will run as many races as possible within time limit.

No race shall start after 4:00 PM.

Pack up Boats, equipment, gear.

Awards @ Grosse Pointe Yacht Club to follow.
