#### 1. Rules:

- 1.1 The regatta will be governed by the Racing Rules of Sailing 2021-2024, the prescriptions of US Sailing, ISSA Procedural Rules, MISSA District rules, this Notice of Race, and the Sailing Instructions. In the event of a conflict between the governing documents, the Sailing Instructions will take precedence.
- 1.2 ISSA Rule 5.1 will be strictly enforced. Any participant breaching this rule will result in immediate disqualification from the regatta and removal from Culver property for that participant and their team. Entering the regatta constitutes participant agreement with this rule and penalty.
- 1.3 The organizing authority is MISSA in conjunction with Culver Academies.

#### 2. Eligibility:

- 2.1 This is a MISSA Tier 2 regatta, open to all MISSA teams in good standing.
- 2.2 The regatta is limited to 16 teams. Additional teams will be added to a waitlist.
- 2.3 This regatta is a qualifier for the ISSA National Keelboat Invitational at St. Petersburg Yacht Club, Florida on December 10-11, 2022. The winning team must accept their berth in accordance with MISSA District Rule 5.11. If the berth is not accepted by the deadline it will be offered to the next qualified team by the MISSA President.
- 2.4 Teams shall be comprised of a crew of 4. At least one boy and one girl must be on the crew at all times.

#### 3. Entry and Communications:

- 3.1 Teams may enter by filling the form and paying the Entry Fee at the **MISSA Registration** site by 2300 Eastern Time on Sunday, September 23, 2022. All entries must be made through the site.
- 3.2 Each school may enter one team.

- 3.3 Each team must complete an Entry Form with waiver. The Entry Form must be completed and submitted before the end of registration on Saturday October 1. Incomplete or missing forms will result in the respective team/school being excluded from the regatta.
- 3.4 Entered teams unable to compete must notify the Regatta Chairperson and their MISSA representative as soon as possible. All entry fees are final and nonrefundable after 1700 Eastern Time on Friday, September23. Registrations are not transferable between teams.

## 4. Entry Fee

- 4.1 The entry fee is \$200 per team. This includes 2 breakfasts and 2 lunches. Each team will receive 2 breakfast and 2 lunch tickets free for 1 coach/parent/chaperon. Team leaders, coaches, and parents can buy additional meal tickets for \$10 each, cash only, during registration from 0700-0800 Saturday.
- 4.2 All entry fees must be submitted through the MISSA Registration site.

## 5. Damage Deposits

5.1 A damage deposit of (\$500.00) **per boat** is required. The refundable boat damage deposit may be submitted via mail before the regatta, or in cash or check at regatta registration. Schools that fail to do so will not compete. The deposit is refundable provided all equipment and boats are returned undamaged. All boats will be inspected prior to and after sailing for preexisting and new damage. Checks should be made payable to Culver Academies.

#### 6. Housing

- 6.1 Woodcraft Camp Cabins will be available on a first-come, first-serve basis. They are for athletes and a coach/chaperons. They sleep 12 athletes plus the <u>required</u> adult chaperon in a separate single room. Multiple schools may share a cabin. Please make these arrangements between teams, then notify the Regatta Chair. <u>Please note</u>: the accommodations are quite utilitarian the cabins are unheated with separate bathroom buildings. There will be designated male/female cabins, *not co-ed*. Bunk beds with mattresses are provided. Bathrooms <u>do</u> have hot water and showers. <u>You will need to supply your own pillows, bedding/sleeping bag, and towels</u>.
- 6.2 Cabins must be reserved by 1700 Eastern Time on Friday, September 23. Please pay for your cabin at the **Eventbrite** site, after paying the school's *entry* and *registration fees on the MISSA site*.
- 6.3 Check-in for housing will be between 1800-2100 Eastern Time on Friday or during registration on Saturday morning.
- 6.4 Cabins will be inspected prior to check-out on Sunday at 1430 Eastern Time. Schools will be charged from their damage deposit if their respective cabin(s) are damaged or left excessively messy.

- 13.2 The race organizers (organizing authority, race committee, protest committee, host organization, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
