## NOTICE OF RACE

- 1. RULES:
- 1.1. The regatta will be governed by the Racing Rules of Sailing, the prescriptions of US SAILING, the ISSA Procedural Rules, MISSA District Rules and By-Laws, this Notice of Race, and the Sailing Instructions. In the event of a conflict between the governing documents and the Sailing Instructions the latter shall take precedence.
- 1.2. RRS Appendix P is in effect modified per ISSA Procedural Rule 14(c).
- 1.3. The Organizing Authority (OA) is the Midwest Interscholastic Sailing Association (MISSA) in conjunction with host Pontiac High School Sailing/PSEF.
- 2. ELIGIBILITY:
- 2.1. Competing schools must be members of MISSA and schools and sailors must meet MISSA eligibility rules. This is a MISSA Tier 1 Regatta.
- 2.2. All sailors must be listed on their team's official roster registered online with ISSA.
- 2.3. Teams must be accompanied by a designated adult team leader, who may be an advisor, coach or parent recognized by the school.
- 2.4. Selection of competing schools will be by qualification. The regatta has 20 berths. WEST 6, East 7, Central 7. The top 4 teams will earn a berth to the Mallory Championships, May 11 and 12 in Seattle, WA. The next 4 teams will earn berths to the Phoebe Kings regatta in Annapolis, May 11 and 12. Berths must be accepted as in MISSA District rule 5.11. Deadline is 12 noon, Central time on , on April 30.
- 3. ENTRY AND COMMUNICATIONS:
- 3.1. Eligible schools and sailors must enter on the MISSA site. All registrations are final, there are no refunds. Register here. <u>http://missa.hssailing.org/event/home/</u><u>missa-mallory-qualifier/351</u>. Dead line is 5pm Eastern on Friday, April 19th.
- 3.2. Teams unable to compete must notify the regatta chairperson, MISSA President and Area VP as soon as possible.

- 4. ENTRY FEE:
- 4.1. The entry is (\$60) per Sailor. This includes breakfast and lunch both days, and a regatta gift. Parents can buy additional meal packages for small donations.
- 5. DAMAGE DEPOSIT:
- 5.1. A damage deposit of (\$200) must be submitted by the morning of regatta. This is refundable if the boat and gear are returned undamaged. In the event damage cannot be attributed to a particular team, the repair costs will be divided evenly amongst all the competing teams.
- 5.2. Make damage deposit checks payable to: CD SAILING.
- 5.3. Boatswain rule. If there is any contact or damage on the water, you must see the boatswain immediately following that race. Boatswain will be on the Starboard side of Signal start boat.
- 6. BOATS:
- 7. Twenty C 420's will be provided, Boats will be sailed is.
- 7.1. Each coach is expected to provide a coach boat and to assist with boat rotations. Coaches of teams from the west area should contact the regatta chair immediately upon registration to inquire about the possibility of alternative arrangements.

- 8.1. All races will be sailed on Cass Lake.

- 9.1. Based on conditions, the Race Committee will determine the courses as prescribed in ISSA PR 7.7.
- 10. SCORING:
- 10.1. The regatta will be scored in accordance with ISSA Procedural Rules.

COACHING: Coaches may go afloat near the starting area, but must stay a minimum of 100 yards away from the racing area at all times and may not communicate with a participant at any time while that participant is racing.] Only coaches registered with MISSA will be on the water, one coach boat per school. Rotations will be on the water.
- 13. PRIZES AND QUALIFICATION: Awards will be given to the top 4 teams.

14. OFFICIAL NOTICE:

14.1.No contestant shall use, either on or off the water, marijuana or any other controlled substance.

- 15. RIGHTS TO USE NAME AND LIKENESS:
- 15.1.By participating in this event, competitors automatically grant to the Organizing Authority and the event sponsors the right, in perpetuity, to make, use and show, at their discretion, any photography, audio and video recordings, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.
- 16. WAIVER OF LIABILITY:
- 16.1.Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 4, Decision to Race.
- 16.2. The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
