Location: Culver Academies Naval Building, Lake Maxinkuckee, Indiana.

Class: 420

Tier 2 Regatta

1. Rules:

- 1.1 The regatta will be governed by the Racing Rules of Sailing 2021-2024, the prescriptions of US Sailing, ISSA Procedural Rules, MISSA District rules, this Notice of Race, and the Sailing Instructions.
- 1.2 In accordance with Rule 70.5(a) and ISSA PR 20, the decisions of the protest committee are final. US Sailing's permission has been granted.
- 1.3 In the event of a conflict between the governing documents, the Sailing Instructions will take precedence.
- 1.4 The organizing authority is MISSA in conjunction with Culver Academies.

2. Qualification:

- 2.1 This event is a qualifier for the Great Lakes Championship. The first through fourth place teams will earn a berth to both the Great Lakes Championship. If a team had previously qualified for the Shepherd Championship, it vacates its berth to Shepherd when it accepts its berth to Great Lakes, and the MISSA District Director will reallocate that Shepherd berth to the next team in line from the qualifier at which it was earned.
- 2.2 This event is also a qualifier for the Shepherd Championship. The top three finishing teams which have not otherwise qualified for either the Great Lakes Championship or the Shepherd Championship will earn berths to the Shepherd Championship.
- 2.3 All berths not accepted in accordance with MISSA Rule 5.10 will be reallocated by the MISSA District Director.

3. Eligibility:

3.1 Competing schools must be members of ISSA and meet ISSA eligibility rules as prescribed in Procedural Rules Part III.

- 3.2 Only MISSA teams in good standing which have not previously qualified for the Great Lakes Championship are eligible to compete. If a team registers for this regatta and subsequently qualifies for the Great Lakes Championship, its registration will be canceled, fees will be refunded, and it will not be eligible to participate.
- 3.3 All teams are required to have a designated on the water coach for safety and boat rotations.

4. Entry and Communications:

- 4.1 Teams can enter by paying the Entry Fee at the **Eventbrite** site by 2330 Eastern Time on Friday, October 14. All entries must be made through the site.
- 4.2 Each school may enter one team (1 A Division and 1 B Division) with or without alternates. Mix teams are not allowed. All competitors must be grade 9-12.
- 4.3 Each team must complete and Entry Form and waiver. The Entry Form must be completed and submitted before the end of registration on Saturday October 8. Incomplete or missing forms will result in the respective team/school being excluded from the regatta. Forms are to be emailed to joe.hanko@culver.org.
- 4.4 Entered teams unable to compete must notify the Regatta Chairperson and their MISSA representative as soon as possible. All entry fees are final and nonrefundable after 2330 Eastern Time on Friday, October 14, 2022. Registrations are not transferable between teams.

5. Entry Fee

- 5.1 The entry fee is \$200 per team, \$50 per additional sailor. This includes lunch Saturday and Sunday.
- 5.2 All entry fees must be submitted through **Eventbrite**.

6. Damage Deposits

6.1 A damage deposit of (\$250.00) **per boat** is required. The refundable boat damage deposit may be submitted via mail before the regatta, or in cash or check at regatta registration. Checks should be made payable to Culver Academies. Schools that fail to do so will not compete. The deposit is refundable provided all equipment and boats are returned undamaged. Any school that modifies, changes, or otherwise improperly rigs their boat's rigging, halyards, or other equipment and components, will be charged the necessary amount from their damage deposit to return the boat to its pre-race condition.

7. Housing

- 7.1 Woodcraft Camp Cabins will be available on a first-come, first-serve basis. They are for athletes and a coach/chaperon. They sleep 12 athletes plus the <u>required</u> adult chaperon in a separate single room. Multiple schools may share a cabin. Please make these arrangements between teams, then notify the Regatta Chair. <u>Please note</u>: the accommodations are quite utilitarian the cabins are unheated with separate bathroom buildings. There will be designated male/female cabins and bathrooms/showers. Bunk beds with mattresses are provided. Bathrooms <u>do</u> have hot water and showers. <u>You will need to supply your own pillows</u>, bedding/sleeping bag, and towels.
- 7.2 Cabins must be reserved by 2330 Eastern Time on Friday, October 14 through the **Eventbrite** Site. Culver Academies cannot guarantee cabin availability.
- 7.3 Check-in for housing will be between 1800-2100 Eastern Time on Friday, October 21. Schools may also check-in to receive their cabin assignment during registration on Saturday morning from 0800-0830 Eastern Time.
- 7.4 Cabins will be inspected prior to check-out on Sunday at 1430 Eastern Time. Schools will be charged from their damage deposit if their respective cabin(s) are damaged or left excessively dirty.

8. Boats

- 8.1 24 C420s will be provided by Culver Academies. Boats will be sailed as provided. Competitors may bring telltales for shrouds.
- 8.2 Dock space is available for visiting team coach boats. A limited number of Whaler 17's may be available for visiting coaches.

9. Regatta Format

- 9.1 This is a two-division (A and B) regatta. Boat rotations will occur per the rotation schedule in Techscore.
- 9.2 Rotations may take place from shore or coach boat as designated by the OA. To rotate from shore the incoming crew will meet the outgoing crew while the boat is afloat at the beach. A coach, chaperon, parent, or other support personnel affiliated with the school **must** be present to assist with rotations.

By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
