Tier 3 Regatta

1. Rules:

- 1.1 The regatta will be governed by the Racing Rules of Sailing 2017-2022, the prescriptions of US Sailing, ISSA Procedural Rules, MISSA District rules, this Notice of Race, and the Sailing Instructions. In the event of a conflict between the governing documents, the Sailing Instructions will take precedence.
- 1.2 The organizing authority is MISSA in conjunction with Culver Academies.

2. Eligibility:

- 2.1 Competing schools must be members of ISSA and meet ISSA eligibility rules as prescribed in Procedural Rules Part III.
- 2.2 While on the Culver campus, teams must be accompanied by a designated adult team leader, who may be an adviser, coach, or parent recognized by the school.
- 2.3 ISSA Rule Part III, 5.1 will be strictly enforced. Any breach of the rule will result in the competitor's entire team being disqualified and immediately removed from the regatta site. The regatta site includes all Culver Academies property.

3. Entry and Communications:

- 3.1 Schools can register by submitting the official Entry Form by <u>1700 Eastern Time on Friday, May 6, 2022</u>. All Entry Forms must be emailed to the Regatta Chairperson.
- 3.2 Each school will enter one team (1 A Division and 1 B Division) with or without alternates.
- 3.3 If the Entry Form is incomplete at 1700 Eastern Time on Friday, May 6, 2022, the respective team/school may lose their berth in the regatta.
- 3.4 Entered teams unable to compete must notify the Regatta Chairperson and their MISSA representative as soon as possible. All entry fees are final and nonrefundable after 1700 Eastern Time on Friday, 1 May 6, 2022. Registrations are not transferable between teams.

3.5 If there are unfilled berths in the regatta by the entry deadline, late entry of additional teams will be allowed beginning 1730 Eastern Time, Friday May 6 through 1700 Eastern Time, Friday May 13, 2022. Wait list entry will be available on the <u>EventBrite</u> site. Please contact Regatta Chairperson for more information.

4. Entry Fee

- 4.1 The entry fee is \$100 per team of four sailors. Additional sailors are \$25.00 each. Food is not included.
- 4.2 All entry fees must be submitted through <u>EventBrite Ticket Sales</u> by <u>1700 Eastern Time on Friday, May 13,</u> <u>2022</u>.

5. Damage Deposits

5.1 A damage deposit of (\$250.00) **per boat** is required. The refundable boat damage deposit may be submitted via mail before the regatta, or in cash or check at regatta registration. Schools that fail to do so will not compete. The deposit is refundable provided all equipment and boats are returned undamaged. All boats will be inspected prior to and after sailing for preexisting and new damage. Any school that modifies, changes, or otherwise improperly rigs their boat's rigging, halyards, or other equipment and components, will be charged the necessary amount from their damage deposit to return the boat to its pre-race condition.

6. Housing

- 6.1 Woodcraft Camp Cabins may be available on a first-come, first-serve basis. Available cabin tickets will be posted on the Eventbrite site. They are for athletes and a coach/chaperone. <u>Please note</u>: the accommodations are quite utilitarian the cabins are unheated with separate bathroom buildings. Bathrooms do have hot water and showers. <u>You will need to supply your own pillows, bedding/sleeping bag and towels</u>. There will be designated male/female cabins, *not co-ed*. Cabins must be reserved by 1700 Eastern Time on Wednesday, May 11, 2022. They sleep 12 athletes plus the <u>required</u> adult chaperon in a separate single room. Multiple schools may share a cabin, arrangements made by the schools.
- 6.2 Cabins are to be reserved by contacting the Regatta Chairperson once the school's *entry* and *registration fees*, have been submitted. Culver Academies cannot guarantee cabin availability until these have been submitted.
- 6.3 Check-in for housing will be between 1800-2100 Eastern Time on Friday, May 13, 2022. Schools may also check-in to receive their cabin assignment during registration on Saturday morning from 0700-0800 Eastern Time.
- 6.4 Cabins will be inspected prior to check-out on Sunday at 1430 Eastern Time. Schools will be charged from their damage deposit if their respective cabin(s) are damaged or left excessively messy.

7. Boats

7.1 24 C 420s will be provided by Culver Academies. Boats will be sailed as provided. Equipment of any kind will not be substituted. Competitors may bring telltales for shrouds.

8. Rotations

- 8.1 This is a two-division (A and B) regatta. Initial boat assignments and rotations will occur in accordance with the rotation schedule published in Techscore.
- 8.2 Rotations may take place from shore, dock, or coach boat as designated by the OA. To rotate from shore the incoming crew will meet the outgoing crew while the boat is afloat at the beach. A coach, chaperon, parent, or other support personnel affiliated with the school **must** be present to assist with rotations.

By submitting registration the respective school agrees and guarantees reimbursement to the Culver Educational Foundation in the event of such loss or damage.

- 13.1 Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 4, Decision to Race.
- 13.2 The race organizers (organizing authority, race committee, protest committee, host organization, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
