**NOTICE OF RACE**

**1. RULES:**

- 1.1. The regatta will be governed by the current Racing Rules of Sailing, the prescriptions of US SAILING, the ISSA Procedural Rules, the NESSA Procedural Rules, this Notice of Race, and the Sailing Instructions (available at Registration).
- 1.2. In accordance with RRS 70.5(a), decisions of the protest committee are final. US SAILING's permission has been granted.
- 1.3. ISSA PR 5.1 (Conduct) shall be in effect for the entire regatta.
- 1.4. The Organizing Authority (OA) is NESSA in conjunction with MVRHS sailing team and Sail Martha's Vineyard.
- 1.5. ISSA PR 2.5 (Pinnies) is in effect.

**2. ELIGIBILITY:**

- 2.1 The regatta is open to both NESSA and non-NESSA teams, but priority goes to fully registered NESSA teams (please see 2.3).
- 2.2 ISSA PR 1.3 is in effect. Teams must be accompanied by a designated adult team leader, who may be an advisor, coach or parent recognized by the school.
- 2.3 **Article K, section 3 Qualification** is in effect, as this is a qualifier for the ACC Regatta in November.  
Schools shall be eligible for NESSA Invitational Regattas in the following way.
  1. All NESSA dues must be paid
  2. Each NESSA Member school is entitled to one entry on a first come, first served basis until the regatta is filled.
  3. Non-NESSA teams (conglomerate teams or out of district school teams) are entitled to sign up when the registration opens for a NESSA Invitational Regatta. Entry in the said regatta will be granted to a Non-NESSA team after 10 days from when registration opens, only if space is available, at a first come first serve basis.

**3. ENTRY AND COMMUNICATIONS:**

- 3.1 Eligible schools wishing to register for this event should use event link on the ISSA/NESSA website (PASTE LINK HERE).  
Registration opens at 0900, September 4th, 2021.
- 3.2 10 berths are available on a first come-first served basis.
- 3.3 The event chair reserves the right to increase the number of berths at his discretion.
- 3.4 Registration will begin at 9am on September 1<sup>st</sup> and close open until Tuesday September 16<sup>th</sup> at 0900.
- 3.5 All teams still wishing to compete after registration is filled will be added to a waitlist.
- 3.6 Teams that have registered and are unable to compete must notify the regatta chairperson as soon as possible. Any cancellation later than Thursday, September 16<sup>th</sup> at 0900 hours, or failure to field a registered team that results in another team being denied a berth, will result in applicable sanctions prescribed by NESSA By-Laws Article L.

**4. ENTRY FEE:** The entry is **\$25 per team**. **PayPal link on Registration page**

**5. BOATS:** C420s

**6. SCHEDULE:**

0815 Ferry departs from Woods Hole (arrives 9am in Vineyard Haven)  
0930 Check in  
1000 Competitors meeting  
1600 No A Division races will be started after this time

- \* Return ferry schedule is: 1700, 1815, 1930
- \* Changes to the schedule will be posted on the official Techscore page.
- \* Additional transportation information will be sent to all registered teams.

**7. FORMAT:** A and B fleet racing.

**8. RACING AREA:**

8.1 All races will be sailed in the Lagoon off of the Sail MV boathouse or the Vineyard Haven outer harbor off of the VHYC.

8.2 All registrants will be notified prior to event and transportation will be provided to both venues

**9. COURSES:** Courses will be in accordance with ISSA PR 7.7

**10. SCORING:** The regatta will be scored in accordance with ISSA PR 11. All scoring will be done through Techscore and there will be no physical RP forms available. Please make sure your team is registered properly and that team members are updated on ISSA prior to the event. **11. PRIZES:** The Arnold Brown trophy will be awarded to the winning team and they will also receive a NESSA berth the 2021 ACCS

**12. RIGHTS TO USE NAME AND LIKENESS**

By participating in this event, competitors automatically grant to the Organizing Authority the right, in perpetuity, to make, use and show, at their discretion, any photography, audio and video recordings, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.

**13. WAIVER OF LIABILITY:**

Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 4, Decision to Race. The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.

**14. COVID PROTOCOLS:** Masks must be worn for anyone entering the boathouse and we will strongly encourage everyone to limit entering the building except for changing. Masks do not need to be used while outdoors.
