Format: This regatta will be a NESSA (varsity) and open class regatta as a team racing event.

Boats: Turbo 420s

Rules: ALL ISSA Procedural Rules will apply Except sailor eligibility. This event is open to any high school team, including conglomerate teams, at the discretion of the host.

Protests: Protests shall be filed with the race committee at the end of the race the foul has occurred in. All protests must then be formally filed with the race committee within 30 minutes from when the RC boat hits the dock. This time will be posted. Protest hearings will be conducted by volunteer coaches who are, by the best our of abilities, unbiased.

Competitors: ISSA Procedural Rule 1.2 is in effect. All competitors must be full time students, in the 9th grade or higher, of the school they represent. A student is considered to be in his or her grade for the school year, including past graduation or advancement to the next level, until the new school year starts.

Pinnies Required: ISSA Procedural Rule 2.4 is in effect.

Conduct: ISSA PR 5.1 (Conduct) shall be in effect for the entire regatta

Eligibility: Schools shall be eligible for NESSA Invitational Regattas in the following way. 1. All NESSA dues must be paid.

2. Each NESSA Member school is entitled to one entry on a first come, first served basis until the regatta is filled.

3. Registration for non-NESSA teams(conglomerate teams or out of district school teams) will open after Wednesday, May 11, only if space is available, on a first come first serve basis. 4. Registration will be open to the first 8 teams.

Registration: Please register by e-mailing the Event Coordinator with the following information:

- -Name of school
- -Contact person's name (coach or advisor)
- -E-mail Address
- -Phone Number

Registration is on a first come first serve basis. A wait-list will be assembled if the event becomes full.

Cancellation: Cancellation 48 hours prior to the event will carry no penalty. A team that cancels within 48 hours of the event shall forfeit to the teams in attendance at the event.

Courses: The course will be a Digital N

Scoring: The regatta will be scored on tech score.

Coaching:

1. Team leaders, chaperones, coaches, parents, advisors and other support personnel shall not go afloat in the sailing area from the time they arrive at the regatta site until the regatta is done unless explicitly permitted by the regatta chair. The penalty for failing to comply with this requirement may be the disqualification of all boats, competitors and teams associated with the infringing support personnel. 2. A coach who is also acting as a Race Committee is exempt from PR 8(a) between sets of races. 3. ISSA PR 8 defines other coaching limitations and obligations.

Waiver of Liability:

- 1. Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 4, Decision to Race.
- 2. The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
