# 'Trick-or-Treat' Open Team Race Regatta - Notice of Race Hosted by Sail Orcas & OIYC

West Sound, WA

October 27 & 28, 2018

## 1. RULES

- 1.1 The regatta will be governed by the Racing Rules of Sailing for 2017-2020, including Appendix D, the prescriptions of US SAILING, the ISSA Procedural Rules, this Notice of Race, and the Sailing Instructions.
  - A. The US Sailing prescriptions to rules 60, 63.2, and 63.4 will not be in effect; and
  - B. Races will be umpired per the guidelines and protocols outlined in Section 12 of the ISSA Procedural Rules.

# 2. ELIGIBILITY

- 2.1 Current ISSA and NWISA membership is required and will be verified at the time of final registration at the regatta site.
- 2.2 A responsible adult leader must accompany teams at all times.
- 2.3 The regatta is an open regatta as defined by the NWISA District Rules.

## 3. ENTRY AND COMMUNICATIONS

- 3.1 Registration opens Monday October 15<sup>th</sup> at 11:00am. Please register via the online spreadsheet which can be found on the schedule page of nwisa.hssailing.org.
- 3.2 Registration shall be completed online no later than Monday October 22, 2018 at 10pm.
- 3.3 Teams unable to compete shall notify the Regatta Chair as soon as possible.
- 3.4 Entry Fee is \$10 per participant and includes dinner on Saturday night as well as some snacks on Saturday and Sunday. Please make checks payable to: Sail Orcas.
- 3.5 Groceries are available in Eastsound (10 minutes drive from the venue) at the Island Market and the Orcas Island Food Co-op. Also, the Orcas Village Store has groceries and a great deli. They are located at the Ferry Landing. (Also 10 minutes drive from the venue)
- 3.6 A costume contest will be judged by a panel of coaches during the day on Saturday. Prizes will be awarded Saturday after racing, in a variety of categories that may include commitment, creativity, enthusiasm and combined team spirit.

#### 4. BOATS

4.1 Races will be sailed in CFJs.

## **6. RACING AREA**

- 6.1 The racing area will be as close to shore as the breeze permits, offshore of the OIYC dock and the West Sound Marina.
- 6.2 Rotations will be from the leeward side of the OIYC dock.

## 7. COURSES

7.1 Based on conditions, the Race Committee will determine the courses as prescribed in ISSA PR Appendix 6.

## 8. SCORING

8.1 The regatta will be scored in accordance with ISSA Procedural Rules.

## 9. LODGING

- 9.1 Saturday night housing will be provided for teams with chaperones at the Orcas Middle School Gym. Please contact Hannah ( hannahtt@gmail.com ) to confirm housing.
- 9.2 You must provide your own sleeping bag and pillow.
- 9.3 \*\*Each team is responsible for adult supervision for all sailors at all times during the regatta and while at any provided housing.

#### 11. COACHING

- 11.1 Team leaders, chaperones, coaches, parents, advisors and other support personnel shall not go afloat in the sailing area from the start of racing Saturday to the end of racing Sunday UNLESS an exception has been explicitly permitted by the regatta chair or PRO.
- 11.2 Competitors may receive coaching including instructions, assistance, equipment or sustenance only while on the designated rotation float or on shore.

## 12. OFFICIAL NOTICE FOR ALL PARTICIPANTS

- 12.1 No contestant shall use, either on or off the water, alcoholic beverages (beer, wine, distilled spirits), or use any controlled substance (marijuana, cocaine, etc.), the possession of which is unlawful. An alleged breach of this rule and/or other disciplinary matters that occur may be the basis for a hearing under rule
- 69.1. The protest committee for such a hearing will be the Regatta Chairperson, a member of the NWISA Board of Directors and the chairperson of the protest committee.
