



**Trick or Treat Team Race**  
**October 30-31st, 2021**  
**Olympia, Washington**

**NOTICE OF RACE**

**1. RULES:**

- 1.1. The regatta will be governed by the Racing Rules of Sailing for 2021-2024, including Appendix D, the prescriptions of US SAILING, the ISSA Procedural Rules, the NWISA District Rules and this Notice of Race, and the Sailing Instructions.
- 1.2. Limited umpiring will be used (see rule D2.6 in Appendix D).
- 1.3. The US Sailing prescriptions to rule 60, 63.2 and 63.4 are deleted and will not apply.

**2. ELIGIBILITY:**

- 2.1. Competing schools shall be members of ISSA and meet ISSA eligibility rules as prescribed in the Procedural Rules.
- 2.2. Teams shall be accompanied by a designated adult team leader, who may be an advisor, coach or parent recognized by the school.
- 2.3. Teams shall comprise a minimum of 6 sailors. Multiple teams per school are allowed (limited by boat availability). Teams with less than 6 sailors should contact the regatta chair for help combining with another school.
- 2.4. Team must have a damage deposit on file with NWISA.

**3. ENTRY AND ENTRY FEE:**

- 3.1. Eligible schools shall register at [nwisa.sailing.org](http://nwisa.sailing.org). Registration is on a first come, first served basis. Registration opens October 18th 2021, @1100. Boats will be allocated at this time. Additional registrations are allowed after this time, but teams may be turned away if boats are unavailable.
- 3.2. Teams unable to compete after registration closes shall notify the regatta chair as soon as possible.
- 3.3. There is a \$10 entry fee. Snacks and hot drinks will be provided, possibly breakfast based on registration.
- 3.4. The Olympia Farmers Market is also open, and a 3min walk away.
- 3.5. Regatta Swag - if a regatta Shirt/Item is feasible online ordering will commence early October. We are checking with our local screen printer and will be shared with NWISA list serve.
- 3.6. Lastly, there will be a costume contest on Sunday (Halloween day) prizes will be awarded after racing, sailors must wear costumes while racing!

**4. BOATS:**

- 4.1. FJs and Vanguard 420s
- 4.2. OYC will provide a flight of 420s and a flight of FJs. Attending programs will be asked to bring additional flights of FJs/420s depending on demand/registration numbers.

## 5. SCHEDULE:

### **Saturday, October 30th**

0900 – 1000 Launch boats at Swantown Marina. Get towed over to Port Plaza Dock.

1030 Mandatory Competitors Meeting at Port Plaza.

1100 First warning; sailing will continue throughout the day.

1630 No starts after this time.

### **Sunday, October 31st**

900 Report Time

1030 First warning; sailing will continue throughout the day.

1500 No starts after this time.

## 6. LAUNCHING AREA:

Teams bringing boats are to launch them at the Swantown Marina boat ramp next to the OAR boathouse (where we've launched boats at previous regattas). Address:

## 7. RACING AREA:

Racing will take place at Port Plaza, using the Port Plaza dock to rotate off of. Address:

701 Columbia St NW, Olympia, WA 98501

Parking and public restrooms are located directly behind Anthony's Restaurant at the Olympias Farmer Market.

## 8. COACHING:

8.1. Team leaders, chaperones, coaches, parents, advisors and other support personnel shall not go afloat in the sailing area from Saturday morning to the end of racing Sunday unless an exception has been explicitly permitted by the regatta chair. The penalty for failing to comply with this requirement may be the disqualification of all boats, competitors and teams associated with the infringing support personnel.

8.2. We will have 1 additional/back-up safety launch at the dock. This may be used for Coaches to informally umpire if feasible, and for the benefit of all sailors.

## 9. CONDUCT

9.1. No contestant shall use, either on or off the water, alcoholic beverages (beer, wine, or distilled spirits, each as defined in Chapter 51 of the US Internal Revenue Code and intended for beverage use), or marijuana, cocaine, or any other controlled substance (as defined in 21 US Code 802), the possession of which, by that contestant is unlawful under 21 US Code 841.

9.2. Infringements of this regulation and/or other inappropriate conduct occurring during the regatta, may be the basis for a hearing under RRS 69.1. The protest committee for such a hearing shall, at a time and place selected by it, meet to hear said protest, and it may impose scoring penalties, or other sanctions that it deems appropriate, including summary removal from the regatta.
