**NOTICE OF RACE**

**1. RULES:**

- 1.1. The regatta will be governed by the Racing Rules of Sailing for 2021–2024, the prescriptions of US SAILING, the ISSA Procedural Rules, the NWISA District Rules, this Notice of Race, and the Sailing Instructions.
- 1.2. The US Sailing prescriptions to rule 60, 63.2 and 63.4 are deleted and will not apply.
- 1.3. Under rule 70.5(a), the right of appeal is denied.

**2. ELIGIBILITY:**

- 2.1. This is an 'Open Regatta' as described in the NWISA District Rules. 'Active' and 'Mixed' teams may attend.
- 2.2. Full Teams and mixed teams are allowed and will sail together in Collegiate Rigged 420's and FJ's.
- 2.3. Teams shall be accompanied by a designated adult team leader, who may be an advisor, coach or parent recognized by the school.
- 2.4. All participants of the event will follow proper social distance protocol and wear a mask at all times while on shore.

**3. ENTRY AND ENTRY FEE:**

- 3.1. There is no entry fee. No snacks, lunches, or food will be provided.

**4. COVID-19 AND SAFETY:**

- 4.1. This event will be limited to vaccinated individuals only. **Coaches** will need to show proof of vaccination or a negative covid test dated within 3 days of the event **for all sailors participating in the event**. Coaches should compile this information prior to the event.
- 4.2. Carpools should be limited to household units during travel, otherwise masks should be worn or separate vehicles should be used.
- 4.3. Hygiene and cleanliness should be maintained as much as possible.
- 4.4. All team activities should remain outdoors and on-shore interactions between teammates and coaches should be socially distanced whenever possible.

**FACE COVERINGS:**

- Masks or doubled over gaiters must be worn on shore and on the docks.
- While racing, sailors should follow the policies of their own team.
- During wet or windy conditions, sailors are encouraged to remove face coverings while sailing, especially if multi-layered cotton.

**5. BOATS AND FORMAT:**

- 1.1. This regatta will be sailed in Fjs. WSC has 10 Fjs, and teams are encouraged to bring additional boats if registration for the event exceeds the number of boats WSC has to offer.

## **SCHEDULE:**

10:45am	First warning; sailing will continue throughout the day
3:30pm	No Race shall be started after that.

#### Special Notes to the Schedule:

- Sailors should bring their own food and water.
- Any changes to the schedule will be posted on the Official Notice Board as soon as possible with all attempts made to allow at least one hour prior to the change going into effect.

Any changes to the schedule will be posted on the Official Notice Board located on the east side of the WSC clubhouse.

## **6. RACING AREA:**

- 6.1. All races will be sailed on the Willamette River just to the east of the docks. There will be rotations for this event in standard HS Sailing format.
- 6.2. Viewing areas for spectators will be on the main docks in front of the WSC clubhouse and along the Willamette Greenway walking path.

## **7. COURSES:**

- 7.1. Short collegiate style races in accordance with ISSA Procedural Rules.

## **8. SCORING:**

- 8.1. The regatta will be scored in accordance with ISSA Procedural Rules.

## **TRAVEL AND TRANSPORTATION:**

Teams are responsible for their own transportation.

## **9. COACHING:**

- 9.1. Team leaders, chaperones, coaches, parents, advisors and other support personnel shall not go afloat in the sailing area from Saturday morning to the end of racing on Saturday unless an exception has been explicitly permitted by the regatta chair. The penalty for failing to comply with this requirement may be the disqualification of all boats, competitors and teams associated with the infringing support personnel.
- 9.2. Competitors may receive coaching while on-shore including instructions or assistance,

## **10. CONDUCT:**

- 10.1. No contestant shall use, either on or off the water, alcoholic beverages (beer, wine, or distilled spirits, each as defined in Chapter 51 of the US Internal Revenue Code and intended for beverage use), marijuana, cocaine, or any other controlled substance (as defined in 21 US Code 802), the possession of which, by that contestant is unlawful under 21 US Code 841.
- 10.2. Infringements of this regulation and/or other inappropriate conduct occurring during the regatta, may be the basis for a hearing under RRS 69.1. The protest committee for such a hearing shall, at a time and place selected by it, meet to hear said protest, and it may impose scoring penalties, or other sanctions that it deems appropriate, including summary removal from the regatta.
