The Organizing Authority (OA) is the Pacific Coast Interscholastic Sailing Association (PCISA).

4.1 Entry and Registration is governed by the NorCal One-Day Notice of Series.

4.2 These two regattas have a maximum of 60 entries each (Total Gold & Silver Fleets Combined). If there are more than 60 entries, PCISA will decline entries in the following order: Teams using borrowed sailors; and then one team from each school with the largest number of entries, repeated until the total number of entries is below 60. Teams will be notified of their entry status as soon as possible after the entry deadline.

Individual competitors should contact their Coach(s) and/or Team Parent before contacting the Organizing Authority. In the event they cannot answer your questions, the coach or team parent should contact the NorCal One Day Series Representative:

**COVID-19 Information:** All competitors, and others attending are required to be fully vaccinated (as defined by the CDC) OR have a Negative Covid-19 Test Result during the week beginning January 31, 2022. Each coach will be required to confirm prior to the regatta that all members of their team, support persons and others attending are fully vaccinated or have a negative test result as above. The only exceptions will be those with written medical or religious exemptions issued by a licensed health provider or established religious organization. Face coverings must be worn inside and are highly recommended in crowded outside gatherings.
