1. SCHEDULE OF RACES

3. FORMAT

Anticipated to be a two-division regatta, however the Hosts reserve the right to change format to maximize time available based on number of participants and their input. Teams will rotate per a rotation chart distributed at the Competitor's Meeting.

4. ELIGIBILITY

4.1 All 2018-2019 Member schools of SAISA North are eligible. Any SAISA teams may participate depending upon boat availability. All teams must be members in good standing with SAISA.

4.5 An adult school representative/advisor is required to accompany each team and be responsible for the conduct on and off the water. The team representative, who may be an advisor, coach, or parent, is expected to have full authority to obtain medical treatment for his team members.

5. FEES & REGISTRATION

There are **no Fees**. Registration will be in the form of an e mail sent to mergenthaler.mike@gmail.com, and spots allocated in the order they are received. Once 12 schools have registered, entry shall be contingent upon their ability to bring their own 420 boat in good condition to add to the rotation. All sailors must supply a completed "Waiver of Liability" prior to participating.

8. SAILING INSTRUCTIONS

Sailing Instructions, Course Diagrams and Rotation Charts will be available at the competitors meeting at Lake Norman Yacht Club.

9. BOATS

Club 420's will be used. Twelve (12) will be provided by Lake Norman Yacht Club. Boats will be assigned in the order Registration Packages are received.

10. RACING AREA

Racing will be on Lake Norman near Lake Norman Yacht Club www.lakenormanyachtclub.com/, 297 Yacht Road, Mooresville, NC28117

11. DAMAGE

Damage that requires beyond normal maintenance is considered a serious incident. If the Protest Committee determines that reasonable care was not used and resulted in damage, one or both boats may be disqualified, regardless of any alternative penalties already taken. In extreme cases, either or both boats may be excluded from the rest of the regatta and sailors or teams held financially responsible.

13. DIRECTIONS

Lake Norman Yacht Club (297 Yacht Road, Mooresville) is located north of Charlotte, NC; follow Interstate 77 to Exit 35. Turn West onto Brawley School Road. Go approximately 6.5 miles to a traffic circle (you will pass through ten traffic lights along your way). Exit traffic circle on OPPOSITE side as you entered (pretend it was never there). Go 0.6 miles and turn LEFT on Yacht Road. Go 0.8 miles and turn LEFT into LNYC. After entering gate, turn left and follow the drive to the pavilion.
